## Academic Year 2007-2008

The programme of the M.A.E.I.S. – Anglophone branch took place :

  from January 7<sup>th</sup>, 2008 until February 28<sup>th</sup>, 2008, at the Institut Européen des Hautes Etudes Internationales in Nice,
- from March 3<sup>rd</sup> until March 7<sup>th</sup>, 2008, at the EJB Werbelinsee, Berlin.
  from March 5<sup>th</sup> until May 11<sup>th</sup>, 2008, at the Institut für Europäische Politik, Berlin.

For the academic year 2007-2008, we designed our study programme in order to enable students to analyze international developments, a focus being the process of European integration and the questions linked to the enlargement of the European Union.

The multidisciplinarity of our programme aimed at introducing a unique approach, enriching students' knowledge and understanding of major change in word politics and the meaning of European integration. Therefore, students were encouraged to acquire a more complex and global perspective on contemporary problems of European Integration and Europe's role in the world.

A closer look on Mediterranean and the so-called "southern" states, in Nice and Rome and the Middle and Eastern European countries in Berlin provided illustrative cases for a better understanding of the regions and their individual European context.

## **ORGANIZATION OF THE PROGRAMME**

# THE MODULES

The lectures and the research were composed of four basic, obligatory modules.

For each module, an I.E.H.E.I. professor was in charge of developing the curriculum and teaching. University teachers, namely from French, German and Italian universities, experts from International and European organizations as well as researchers from our partner institutes also contributed to our programme.

Various teaching methods were applied within each module: lectures, conferences, seminars, "tables rondes", debates and discussions. International colloquia or longer seminars that were open to a larger public were also organized for certain modules.

## 1. <u>INTERNATIONAL RELATIONS</u> (169 hours)

An introduction to theories of international relations provided students with a starting point in order to make sense of historical events. Causes of conflicts during and after the East – West – Conflict case the main focus on this class on international relations. Students participated in a simulation game about the dilemmas of collectivaction

The objective of this module was to provide an analytic vision and a synthesis of the fundamental problems European societies are currently confronted with.

In a first sequence, we analyzed the theoretical foundations of the occidental democracies, their different political systems and the major political movements and political parties that evolved throughout the 20th century.

A second sequence concerned globalization, which is a challenge for the occidental democracies and societies alike. We analyzed how this process influenced and altered the major political movements as well as its social and cultural consequences. The restructuring of the big companies was also taken into consideration.

In the sequence in Berlin, we identified the problems that appeared when the democratic and capitalist systems were established in the Middle and Eastern European countries.

#### 4. EUROPEAN INTEGRATION (195 hours 15 min.)

The objective of this module was to analyze the different aspects and procedures linked to European integration and to find out how far the process of European integration and EU enlargement are influenced and accelerated by developments of the outside world. We also reflected on the significance the choice of this form of integration has on an international level and discussed the new challenges the European Union has to face.

Thus, this module was an illustration and an opportunity for the students to make use of the theoretical background acquired in other modules and to analyze a particular case.

Knowing about the procedures, problems and the success of the European integration enables the students to come to a critical and qualified assessment of what is at stake in the future, to draw conclusions as for the most adapted principles of action and to develop their own ideas and vision for future choices and, thus, to go beyond the mere stage of analyzing history.
